## I. CALL TO ORDER

# Richard W. McCallum, M.D., PLFSOM, Faculty Senate President

### III. FACULTY SENATE STANDING COMMITTEE REPORTS

## **Faculty Senate Committee on Research Resources**

Wendy Walker, Ph.D., Research Resources Committee Chair

a. Research Resource Committee Report- Dr. Walker reported that the committee met on November 22, 2022. The committee discussed and agreed that it would be beneficial to expand the committee's membership by adding clinical members, members who are involved with the SARP program, basic sciences, and data analysis. Deborah Clegg, Ph.D., Vice President for Research, TTUHSC El Paso, provided a report on the Institutional Review Board (IRB) external review and the suggestions made by the reviewing body, Huron, and reported on the Cayuse Grant Interface System.

The committee discussed the following potential topics to be addressed by the committee in the coming year:

- Addressing issues with the timing of hiring for research staff that work on grants. Faculty have experienced grant delays due to getting the person on board in time to complete the grant deadline.
- Issues related to the Outlook mailbox size limits
- Issues related to the storage capacity for data
- Potential space to perform clinical research
- Editorial services for grants and manuscript editing
- Staffing for the research core lab and statistical core
- Recommendations and priorities for the coming year to improve research resources
- Availability of clinical research coordinators

#### Discussion:

It was noted that there is already an issue on campus with faculty availability and willingness to serve on committees. It was suggested to have specific roles for committee members and to be careful to not add too many additional members. Dr. Guttmann, Nominating Committee Chair, stated that chairs of Senate committees can request to add additional members to their committees by formally making the request to the Nominating Committee, subject to approval by the Faculty Senate. The Nominating Committee will then put out a campus announcement, soliciting for nominations. Dr. Walker noted that the Research Resources Committee wishes to expand the committee's membership by potentially adding clinical faculty members, members who are involved in the SARP program, basic sciences, and data analysis. Dr. Walker will follow up with the Nominating Committee regarding the exact number of additional committee members.

## **Piper Professor Ah Hoc Selection Committee**

a. Piper Professor Ad Hoc Selection Committee Update- Dr. Loera reported the Piper Professor Ad Hoc Selection Committee received 8 applications, however 1 was incomplete. The committee reviewed and scored 7 applicants. Two individuals were recommended to Dr. Lange, TTUHSC El Paso President, and he selected one faculty member for the award. The complete packet of the selected faculty member has been



submitted. The award recipients will be announced in the spring of 2023.

     Gloria Loera, D.N.P., R.N., MEA-BC, Program Director, Graduate Program and Assistant Professor, GGHSON has been reelected for a second three (3) year Faculty Senator term.

#### IV. NEW BUSINESS

Geoffrey D. Guttmann, Ph.D., Nominating Committee Chair

a. TTUHSC El Paso Research Manual Project

Dr. Guttmann proposed to have a research manual developed for all faculty. The manual should be an online-based, living document which will need to be frequently updated and should be formatted so that all TTUHSC El Paso schools can use it as a guide to conduct research.

Suggested items to be covered in the research manual:

- CITI Training Resources
- Points of Contact for NIH and NSF grants
- Identifying the Resources and requirements to conduct research at TTUHSC El Paso
- Access to policies, procedures and timelines for grants
- Approved Vendors
- Grant management information
- Process for accessing grant funds
- Process of signing off on purchases (signature chain) for approval
- Contracts management
- Processes for hiring staff or faculty to work on grants

#### Discussion:

A Senator stated that there is overlap in regards to grant management between what the Office of Institutional Advancement and the Office of Research. Multiple Senators agreed that the post-award grant administration as well as other processes at TTUHSC EI Paso delay the process of hiring research staff to fulfill the aims of research grants. These barriers are internal and not outside TTUHSC EI Paso since the grant's funds are available, but cannot be distributed from our financial office. Additionally, a Senator added that a mentor program for new faculty would be beneficial to assist with informal mechanisms ensuring the correct steps are taken to get obtain grants. The mentor could be senior faculty from another school that has experience with grants. Dr. McCallum asked for a motion, which was made by Dr. Guttmann, to approve the proposition that the research manual be put together by the Office of Vice President of Research. The motion was second by Dr. Loera, and approved unanimously by the Faculty Senate.

Discussion items to be covered in the research manual:

- Points of contact, especially for NSF grants
- Identifying the Resources and requirements
- Access to policies, procedures and timelines for grants
- Authorized vendors
- Grant management information
- Common resources page for all four (4) schools

- Process of purchasing after receiving funds

## **VI. ROUND TABLE DISCUSSION**

# Richard W. McCallum, M.D., PLFSOM, Faculty Senate President

#### a. Salary Equity

Dr. Loera provided a report regarding her meeting regarding salary equity with KoKo Aung, M.D., M.P.H., Vice President for Faculty Success, TTUHSC El Paso, and Praveen Parachuru, B.D.S., M.D.S., 2021-2022 Faculty Resources Committee chair. Dr. Aung suggested the Diversity and Inclusion Committee revisit the salary equity project on its own and not in collaboration with the Faculty Resources Committee. It was decided to gather more information in order to be informed on identifying which objectives to create and move forward with as a committee to tackle salary equity. The Diversity and Inclusion Committee now has access to data and resources, and are in the process of reviewing them to utilize the content to determine next steps. Dr. McCallum added that it would be important to address the exit interviews and the data that is available to explain why people are leaving TTUHSC El Paso. Dr. McCallum requested a report from Dr. Aung on why people are leaving the university. A request will be made to have Dr. Aung provide a report on exit interview data at the next Executive Committee meeting.

# b. Continuing Education (CE) Credits (Dental School)

Robert A. Danforth, D.D.S., from the Woody L. Hunt School of Dental Medicine shared concerns that the dental school faculty are not able to obtain internal Continuing Education (CE) credits for license renewals; noting that it is inconvenient to search outside the institution or travel to obtain CE credits. It seems like a simple request to have the dental school provide CE internally on a weekly or monthly basis. It was noted that there are administrative barriers that are not allowing the dental school to move forward with providing CE. Another Senator added that you have to be an approved provider to provide the content for CE, just like CME and NCPD. The dental school would like to see this done as soon as possible, as it is vital to the dental school to run efficiently and present itself professionally to the community and state. Dr. Aung oversees the Continuing Medical Education (CME) office, and plans to meet regarding this matter with Richard C. Black, D.D.S., M.S., Dean and Professor, Woody L. Hunt School of Dental Medicine.
