Q&A

- **Q:** What are the issues with getting faculty to join? Is it the recruitment efforts, or the offer?
- A: This search has expanded to more avenues of recruitment, and every effort is being made. The COVID-19 pandemic has made potential candidates less likely to accept interviews, which is unfortunate. The issue isn't recruiting, it's a sense of candidates in general not wanting to interview at this time.
- Q: Will faculty leaving the department affect your residency program?
- A: Yes, with the number of faculty down, it will be difficult this year.

IV. STANDING COMMITTEE REPORT

Michael Parsa, M.D.

Q&A

Q: How does the data on remediation and dismissal compare to the national average?

- A: Dr. Parsa responded that since the data is confidential, we do not have the comparison data. Dr. Perry offers National average data through a link in the WebEx chat, saying that they employ the double matrix prediction model and internal data to access the likelihood of success of our students.
- **Q:** Are academic referrals to this committee automatic? Where do professionalism referrals come from?
- A: Academic referrals first go to Student Affairs, as do professionalism referrals. Student Affairs is the clearinghouse of potential cases and makes all referrals to the committee. All students are given a chance to address the committee and explain their positions.
- **Q:** Is there a process to compare the results of the committee's actions to the interview and admissions process to determine if changes in the selection process are warranted?
- A: Recurring meetings of the leaders of academic affairs took place to discuss students' success. One action that came out of these meetings was the development of pre-matriculation modules for incoming students.
- **Q:** Are the professional issues coming up in 1st, 2nd, 3rd, or 4th year? Are there patterns that can identified?
- A: Professional issues occur across all years. There are no patterns that we see at this time. Dr. Parsa also added that there are no patterns found in the data about when professionalism issues arise.
- **Q:** Do MCAT scores correlate to the number of students repeating the year, or to the pass rates of Step 1 and Step 2?
- A: Dr. Francis responded that many of the students that repeat the year go on to have no other problems, they just need a little extra time to catch up. Hence, by the time the students get to Step 1 and Step 2, their scores are good.

Committee on Student Grading continued	 Q: Are we providing the resources for students who are not top range of MCAT scores to graduate and succeed? A: Dr. Francis responded that yes, we are providing the extra resources, and the students are outperforming their predicted success rates. Early intervention is successful. Our students are doing well both clinically and on shelf exams. Q: How can we counsel students about going into fourth year with predictive tests? A: There are numerous tests, such as Computer Simulated Clinical Examination (CSCE), Shelf exam scores that will be helpful in showing students were they are going, and helpful in advising.

A: We consider student evaluation data, satisfaction data, their performance on exams, clinical encounters, grades at the end of the clerkship, duty hours and many more data points when reviewing the performance. For example, for the clerkship phase review, each of the clerkship directors will present key data from their clerkship and it includes objectives and what they are clinical activities are, how the students are scoring, and whether or not, they are meeting their clinical and expectations. Q: Is there an automatic review triggered by failure to meet structured benchmarks? A: Since we use the continuous improvement process, issues that come up are addressed as they arise and therefore a review is triggered for that issue.







Current Issues/Concerns


- We meet monthly and sometimes more frequently, for time sensitive student issues, to provide recommendations or take action upon students brought to our attention by Student Affairs.




