#### I. CALL TO ORDER

# Abhizith Deoker, M.D., FSOM, Faculty Senate President

Dr. Abhizith Deoker, M.D., FSOM, Faculty Senate President, welcomed attendees and called the meeting to order at 12:05 P.M.

# II. REVIEW AND APPROVAL OF MINUTES

Abhizith Deoker, M.D., FSOM, Faculty Senate President



The minutes from the July 26, 2024 Faculty Senate meeting were sent to Faculty Senators for review prior to this meeting. The minutes were unanimously approved as presented.

#### III. NEW BUSINESS

#### Abhizith Deoker, M.D., FSOM, Faculty Senate President

Blue Cross Blue Shield Health Select Update Phillip Rivera, Managing Director of the Managed Care and Credentialing, Privileging and Provider Enrollment at FSOM presented an update regarding the ongoing contract negotiations with Blue Cross Blue Shield Health Select for patient care services. A contract negotiation has not occurred in the past 12 years, which is a problem since the cost of living has gone up significantly, especially in the last 3-4 years. Blue Cross Blue Shield (BCBS) has updated their fee schedules and this has a potential impact on the quality and ability to hire physicians and provide substantial patient care. BCBS made 50% of their business from TTUHSC El Paso, and there was only a 3-3.5 % gain towards TTUHSC El Paso. The negotiation was needed to make a change. A possible solution would be for TTUHSC El Paso to submit a letter of termination of contract to BCBS, but this would impact the patients' ability to continue care at TTUHSC El Paso since it would be out of network. An update and decision will be announced the following week.

Q: If this proceeds and patients at UMC of El Paso are admitted, they will be in-network in the hospital, but the Texas Tech physicians will be out-of-network. Some patients may not wish to be admitted knowing of these charges?

A: Patients must be notified of this change because they will get a higher bill which will show out of pocket charges.

Q: Is there an option to extend the termination date?

A: Yes. Since I got here a year ago, we started setting up meetings to discuss this but BCBS kept delaying and cancelling. We finally got them to meet and hear our side. But with new laws requiring transparency, they know that others in the El Paso market will follow. BCBS of Texas covers multiple states to include Texas, New Mexico, Indiana, Oklahoma and Illinois.

• Bylaws Revisions Dr. Deoker shared a discussion from the Faculty Senate's Executive Committee meeting regarding bylaws revisions. He announced that Dr. Loera will remain as the Chair of the Ad Hoc Bylaws Review Committee. The committee was originally charged with developing a new committee and the Performance Excellence Committee was proposed. The committee is now charged with developing red-lined bylaws language to eliminate the Nominating Committee while preserving one position similar to the Nominating Committee Chair. This will free up three (3) Faculty Senators to serve as Committee Chairs.

A bylaws approval vote is a major undertaking and requires faculty from all schools to participate, therefore the prior recommendations will be grouped with new changes for one bylaws adoption vote.

## IV. STANDING COMMITTEE UPDATES



#### Faculty Resources Update by Marcos E. Ortega, Ph.D., Faculty Resources Committee Chair

Dr. Ortega reported the Faculty Resources Committee addressed some committee objectives for faculty clarity, including:

- Faculty Retention The committee would like data relating to faculty retention.
- Auxiliary Facilities and Child Daycare The committee discussed these examples and noted a survey could be implemented to determine if there is a need for such amenities.

Dr. Ortega mentioned that space has been an ongoing issue and the funding to provide faculty amenities would be complex. A new faculty member noted their disappointment upon learning no gym is available here for faculty, as this has been available at all previous institutions. Faculty would like a place to go onsite for a 30–45 minute reset. A discussion regarding the gym noted this requires a lot of funding, and space is a second issue. Several years ago, buildings were being considered as gym sites, but faculty noted that clinical and educational spaces have been prioritized. Faculty suggested outsourcing childcare and having an outside entity be responsible for resources in shared space.

Dr. Ortega mentioned that clarity is needed on faculty resources including promotion, tenure, salary adjustments, workload, compensation, and worklife balance. The committee would like to gather data by conducting a survey asking faculty which amenities would be of great service to faculty and provide substantial accommodations.

Q: What is the knowledge gap being addressed by the survey?

A: The knowledge gap is understanding increases of salary, promotion, and faculty's roles. The survey may provide feedback on workload, work-life balance, and perspectives on job gratification. We can obtain data over the years to find a trend.

Q: When it comes to surveys you have two problems. One is participation, and the second is some of the departments are scared to fill out these surveys. How would you be addressing these issues?

A: Dr. Ortega responded that it begins individually and with the schools. The issues and concerns that faculty have expressed, do not feel valued or heard, leading faculty not to be vocal and participate. He suggested that the Faculty Senate needs to be a stronger advocate within departments and the schools. Many people do not know what the Faculty Senate does.

Q: I had a question about asking the faculty how they feel about their salary compared to others in their department?

A: This is based on workload. If you think your workload is fair, do you think you are being compensated fairly for what you're doing?

Q: Is there parity in salary across schools? There may be some things going on because we see people moving from one school to another school. A: That was a question on the initial survey, and in some instances, you will get incentivized like some of us already do. We will bring the data to the faculty senate for review and discussion.



#### Research Resources Update by Mingtao Zeng, Ph.D., Research Resources Committee Chair

The Office of Institutional Advancement was invited to present at the Research Resources Committee meeting on how they support faculty research programs through Corporate & Foundation Relations. The presentation was given by Janine Young, Director and Christopher Rosenbluth, Senior Writer.
