I. CALL TO ORDER

Dr. Alok Dwivedi, Faculty Council President, welcomed all attendees joining in-person and via WebEx. He called the January 16, 2024 Faculty Council meeting to order at 12:06 PM. A quorum was present.

The Faculty Council meeting minutes from December 18, 2024 were approved as presented.

III. DEAN'S REPORT

KoKo Aung, M.D., M.P.H.

Vice President for Faculty Success, TTUHSC El Paso, Associate Dean for Faculty Affairs, PLFSOM Dr. Aung provided a report on behalf of the Dean of Foster School of Medicine:

Leadership Recruitment: The Faculty Council officers requested an update from the Dean regarding current leadership recruitment. The medical school's last leadership position recruitment occurred in late 2020 and early 2021 for the Chair of the Department of Orthopaedic Surgery and Recruitment. It culminated in the appointment of Rajiv Rajani, M.D. as department chair. Now, the school is having a rebound after a period of quiet recruitment activity.

- There are now two center director searches for the Director of the Center of Emphasis for Neurosciences and the Director for the Center of Emphasis for Diabetes and Metabolism. Both searches are conducted in-house by the executive leadership recruitment team in the Office of Faculty Affairs.
- There are two chair searches for the Department of Family and Community Medicine and the Department of Radiology. The search committees have been formed and have met. The WittKieffer recruitment search firm has been retained for the radiology chair recruitment. The recruitment for the chair of Family and Community Medicine will be done in-house. Both searches are at the stage of preparing the candidate and institutional profile. The search committee chairs have met with key players including the hospital leadership, the faculty, residents, educational leaders, clinical service leaders, and research leaders.
- WittKieffer has also been retained for recruitment of the Foster School of Medicine dean. The firm is meeting with key players and developing the institutional and candidate profile.
- The sixth upcoming recruitment search is for the chair of the Department of Pediatrics. J. Manuel de la Rosa, M.D., has been appointed as the interim chair. A search committee will be formed and launched soon.

Dr. Aung thanked those participating in the search committees. He noted that the school needs to be strategic in forming committees and bringing candidates for interviews so that one person is not serving on multiple

search committees since committee service is a big time commitment. We do not want to over-tax anyone but make it as evenly distributed as possible.

Q&A

Q: Is a search for a Director of the Center of Emphasis in Infectious Diseases planned?

A: Not at this moment. There are a few leadership searches that are intentionally delayed so the processes are not being conducted simultaneously.

Q: Who decides when a search firm is used?

A: It is the combined decision of the dean and the search committee chair with my input as well. These decisions are not set in stone. If we don't get traction along the way, we can retain a search firm at a later stage. Search firms are not inexpensive. We retain a firm with the expectation they will do a lot of the leg work, but there are times they turn around and ask us to do this. Dr. Edward Michelson is the Chair of the Family and Community Medicine search committee, and he also chaired the search committee as an in-house search without a search firm, which resulted in Dr. Rajani's recruitment.

Q. Are the figures for the deliveries that you reported total deliveries, everything included?

A: Yes, all deliveries. We have level 4 maternal designation for higher risk referrals.

Q. Do we refer patients for any special care?

A: Yes, we have level 4 maternal designation and so we are getting all those higher risk referrals.

Q. How long is the rotation in UC Davis and Alpine? Does the program pay for the travel?

A: It is a two week rotation. The program pays for the travel.

- **Q.** I don't think we have the title of instructor in my department. What is the difference in the role of Instructor vs. Assistant Professor?
- **A:** Someone else may be able to answer that. The rank of instructor tends to be awarded when they are straight out of residency. Instructors have a full faculty role. Upon achieving board certification, an instructor is eligible for promotion to assistant professor.

- Q. Since Step 1 is now pass/fail, I have been experiencing an influx of emails from students who are under the impression that research is now an avenue to boost their application when applying to residencies. Is that being communicated in your committee as far as how to address the desire to engage in research in the first and second year of medical school?
- **A.** The students are looking for a way to distinguish themselves. We do not know how that is going to fall out yet and what each program is going to use to filter their applications. A lot of pressure has fallen on Step 2 since there is still a score there. The students do not find out their Step 2 score until right before they are applying. It is a hard spot for students.

Dr. Thwe Htay, Assistant Dean for Student Affairs, agreed. She noted a lot of programs are looking at the Step 2 score which is received about 2-3 months before the application for residency. We also prepare students for research, scholarly activity, and clerkship. This is the first year that we have students apply with Step 1 pass/fail. Nationwide, we are looking at different ways to prepare students who apply for very competitive residency programs. Currently we are advising students to have two specialties in mind, one competitive and one less competitive, until they get their Step 2 score. We have not received the results for the match yet which is coming up in March.





Step 1 Performance Trends Relative to the National Group (2020 to 2022)






Foster School of Medicine strives to recruit, develop, and retain those best prepared to support its mission.

With these intentions, and mindful of our setting, regional history, and status as a state sponsored school in Texas, the Paul L. Foster School of Medicine actively recruits students particularly emphasizes and encourages diversity from the following categories: Students who are from the US/Mexico border region, who are economically disadvantaged, and those who identify as first generation.
